
2. The management has submitted fire certificate for a period of 10 years from fire department vide proceedings 860/AD/FPW/GHMC/2014 dated 09-02-2016.

7. The management has provided adequate playground area as per norms.




The management is hereby informed to submit the proposals for recognition of the school duly fulfilling the conditions as stipulated in the Government Orders issued from time to time.
